<p>What is the federal bureaucracy?</p>	<p>All of the workers, agencies, and department that make up the Executive Branch</p>
<p>What is the name of the speech given by the President to Congress every January?</p>	<p>State of the Union</p>
<p>How can the president influence policymaking?</p>	<p>Propose legislation, appeal to the people, approve/veto legislation, appoint officials who carry out laws</p>

<p>What role is the president fulfilling when he acts as the head of the executive branch?</p>	<p>Chief Executive</p>
